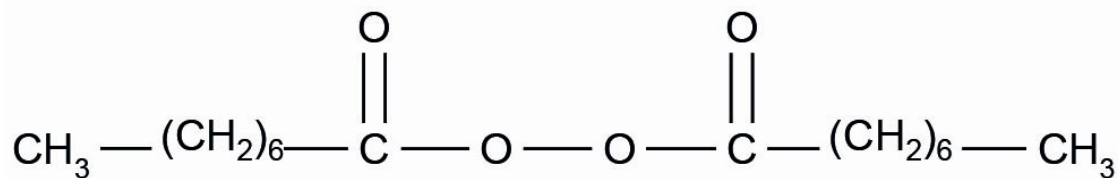

Applications

Polymerization of vinyl chloride - Perkadox SE-8 is an excellent initiator for the suspension and mass polymerization of vinyl chloride in the temperature range 60-75°C.

Half-life data

The reactivity of an organic peroxide is usually given by its half-life ($t_{1/2}$) at various temperatures. The half-life of Perkadox SE-8 in chlorobenzene is:

0.1 hr	at 100°C (212°F)
1 hr	at 80°C (176°F)
10 hr	at 63°C (145°F)

Thermal stability

Organic peroxides are thermally unstable substances, which may undergo self-accelerating decomposition. The lowest temperature at which self-accelerating decomposition of a substance in the original packaging may occur is the Self-Accelerating Decomposition Temperature (SADT). The SADT is determined on the basis of the Heat Accumulation Storage Test.

SADT	25°C (77°F)
Emergency temperature (T_e)	15°C (59°F)
Control temperature (T_c)	10°C (50°F)
Method	The Heat Accumulation Storage Test is a recognized test method for the determination of the SADT of organic peroxides (see Recommendations on the Transport of Dangerous Goods, Manual of Tests and Criteria - United Nations, New York and Geneva).

Storage

Due to the relatively unstable nature of organic peroxides a loss of quality can be detected over a period of time. To minimize the loss of quality, Nouryon recommends a maximum storage temperature (T_s max.) for each organic peroxide product.

Ts Max.	5°C (41°F)
Note	When stored under the recommended storage conditions, Perkadox SE-8 will remain within the Nouryon specifications for a period of at least three months after delivery.

Packaging and transport

In North America Perkadox SE-8 is packed in non-returnable cartons of 44 lb net weight. In other regions the standard packaging is a cardboard box for 20 kg peroxide. Both packaging and transport meet the international regulations. For the availability of other packed quantities contact your Nouryon representative. Perkadox SE-8 is classified as Organic peroxide type C; solid, temperature controlled, Division 5.2; UN 3114.

Safety and handling

Keep containers tightly closed. Store and handle Perkadox SE-8 in a dry well-ventilated place away from sources of heat or ignition and direct sunlight. Never weigh out in the storage room. Avoid contact with reducing agents (e.g. amines), acids, alkalis and heavy metal compounds (e.g. accelerators, driers and metal soaps). Please refer to the Safety Data Sheet (SDS) for further information on the safe storage, use and handling of Perkadox SE-8.
